IdentoGo service codes are no longer searchable on the IdentoGO pre-enrollment website - https://uenroll.identogo.com/. Applicants are directed to the agency program office websites for code lookup and directions. Any service codes that are not made public by the program agency, are provided directly to applicants by the respective agency, and can be used to pre-enroll for a background check.

IDEMIA has a web URL which applicants can access to verify status of background checks. https://uenroll.identogo.com/status-check. Applicants must enter their Universal Enrollment Identification Number (UE ID) and birth date on this website to get access to their information. Applicants are provided a receipt at time of fingerprinting, which identifies their UE ID. Applicants cannot download results of their background checks from this site. Availability of results to applicants, depends on the agency/program office and their respective legislative requirements.
